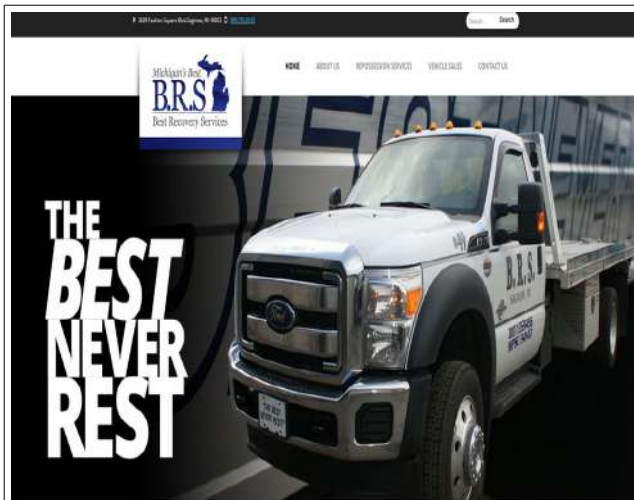

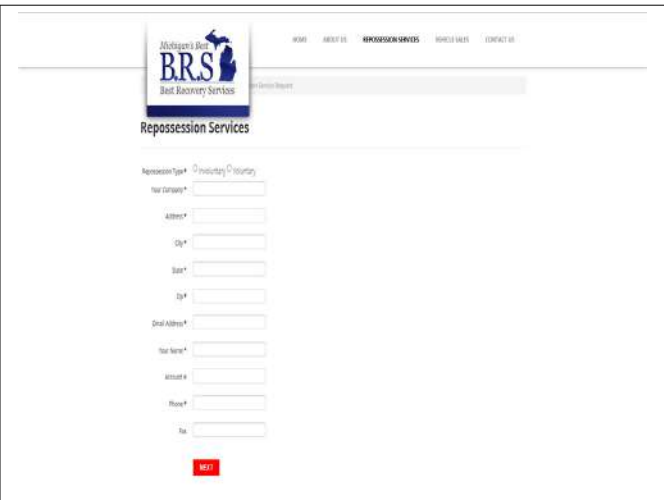

Upon sending an order to BRS, our office staff will assign the order to the proper driver for the territory needed. (Remember: We

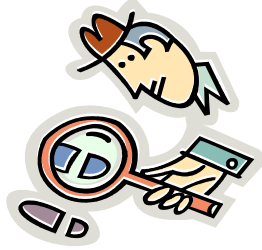
